

# Privacy Policy

## 1. Background

- 1.1 The Certification Board for Inspection Personnel (CBIP) recognises our obligations under the New Zealand Privacy Act 2020 (the Privacy Act) and any other applicable laws and regulations relating to the collection, use, storage and disclosure of your personal information.
- 1.2 Personal information you provide will be managed in accordance with this Privacy Policy.
- 1.3 The Operations Manager is CBIP privacy officer in accordance with the Privacy Act.

## 2. Consent

- 2.1 By using our website for membership and certification applications, you accept the terms of this policy and consent to CBIP collecting, storing, and using your personal information for the purposes for which you provided it.

## 3. Collection of information

- 3.1 CBIP collects personally identifiable information from you when you:
  - apply for membership
  - apply to sit an examination
  - register interest via CBIP's website
  - provide candidate or member feedback
  - lodge an appeal
  - make a formal complaint.
- 3.2 Personal information is also collected during verbal and written communication between you and CBIP such as phone conversations and email messaging.
- 3.3 The information CBIP collects includes your:
  - full, legal name
  - address
  - phone number
  - email address
  - company name and/or employer details
  - professional title
  - relevant qualifications

### 3.4 Personal information is collected:

- for identification purposes
- to enable CBIP to provide its certification services
- from you, not from any third party.

## 4. Use of collected information.

### 4.1 CBIP collects your personal information to:

- provide certification-related services
- meet the requirements of CBIP's accreditation body and the relevant International Standards governing CBIP's accreditation status.

## 5. Storage of Collected Information

5.1 CBIP stores information in digital or non-digital formats.

5.2 Your personal information is retained for the duration of your certification membership following which your information is securely destroyed.

## 6. Disclosure of personal information

6.1 CBIP requires signed confidentiality agreements from all technical personnel and invigilators prior to distributing personal information. This is to ensure verbal and written disclosure of personal information is managed appropriately.

6.2 CBIP may disclose your personal information to third parties where required by the law to a range of organisations. This includes but is not limited to:

- WorkSafe New Zealand
- our professional advisers, including our accountant, internal and external auditors, law firm, insurer.

6.3 If CBIP is required by law to release confidential information, CBIP will notify the person(s) concerned about the information that will be provided unless it is prohibited by law to do so. Notification will include the reasons why the information is being released and the organisation(s) it is being released to.

## 7. Other disclosures

7.1 In addition, CBIP may also disclose personal information:

- with your express or implied consent
- when required or authorised by law
- to an enforcement body when reasonably necessary, or
- to lessen or prevent a threat to an individual or public health or safety.

## 8. Access to Collected Information

- 8.1 You have the right to ask for a copy of any personal information we hold about you, and to ask for it to be corrected if you think it is wrong. - 9.1 CBIP may amend this Privacy Policy from time to time. Any changes apply from the date that the updated Privacy Policy is published on CBIP's website. A change notification will summarise the nature of any changes made and the rationale for those changes.

## 12. Security of Information

- 12.1 When users visit the CBIP website, the system may record certain information about their use of the site, including the web pages visited and the time and date of their visit. Cookies are small text files that help a website to remember the preferences of users to improve the experience of using that website. In some cases, the cookies that we use may collect some personal information. We will treat this information in the same way as other personal information we collect. Users are free to disable cookies on their internet browser to prevent this information being collected; however, they will lose the benefit of the enhanced website experience that the use of cookies may offer.
